Ethical Conduct – including the use of formal codes of ethics	The Trust continues to develop its Code of Conduct in line with the Governance policy document, which gives guidance on the standards of behaviour expected from Trustees. There are also formal meeting guidelines for the owners AGM process.
Trust Board Composition and Performance	The trustees attend training in the area of governance and in the area of benefit to the trust. The Trust Board performance is reviewed annually.
Sub-committees – including composition of committees	Sub-committees are formed to monitor and manage specific aspects of operations, investments or special projects. The committees include trustees and seek external involvement where necessary.
Reporting and Disclosure – including regular reporting and certification of financial statements	The board of trustees reviews annually management reports against budget, including reviewing the annual business plan. In addition they approve the annual financial statements.

However, this is under review because of the excessive costs involved and the fact the Trust has an external and independent party handling all financial transactions.

TRUSTEE REPORT

Tena koutou katoa

In June 2019 we continued our plans to apply for \$250k funding from Te Puni Kokori to develop a feasibility study for a low impact tourism plan based on improving biodiversity on our lands.

We were successful and engaged the services of experts in several areas, scoping options from Oneki (the Neck) to Tutae Ka Wetoweto (Lords River) across lands under the stewardship of RMLT.

The project team included trustees from RMLT, David Bamford and Lisa Choegyal (Tourism Consultants) Roger Lough (Land management Consultant) Real Journeys Ltd (Our partners in our successful Wild Kiwi Encounters) and other key stakeholders including D.O.C, Great South (Southland Regional Development Agency), Rakiura Titi Islands Administration Body, Southland District Council, Stewart Island Promotion Association, Te Runanga o Ngai Tahu and local Runanga.

This resulted in a 64-page application to the Provincial Growth Fund which was essentially the business case for the proposal.

This application was successful, and we are delighted to announce we have been allocated \$2.15 million from the government to start stage one of the Rakiura Oneki Southern Wilderness Experience project (ROSWE). The funding is a \$950,000 PGF grant and \$1.2m PGF loan, and a further \$500,000 from our own funds to meet the \$2.65m phase one budget.

The phase one funding will be used to develop infrastructure on Oneki (The Neck) including an all-weather, biosecurity protected border-wharf at Lowry's Beach, extension of tracks, and building of shelters plus a predator free fence at the south end of Oneki (The Old Neck). Employment opportunities will also be created through the project.

We thank our beneficial owners for backing our vision at the 2019 meeting and we will commit to ensuring you have access to all the updates as the project proceeds.

We will be keeping to our collective Kaupapa of returning our whenua back to what it was when our Tupuna first set foot on Rakiura while at the same time providing low impact restorative visitor opportunities.

The first phase of what is a potentially 20-year long term development will get underway soon.

Oneki (The Neck) has the potential to become a high-profile environmental restoration project in Aotearoa/New Zealand and a World-Class heritage experience showcasing conservation/restoration and Māori cultural and historical activities, while allowing visitors to be part of the project.

The new funding will help with the development of guided walks, letting visitors see biodiversity restoration in action. Many other visitor opportunities were also being investigated.

The project has strong community and key stakeholder endorsement and trust in the way it is being developed, and has the full support of Southland Rūnanga, Te Rūnanga O Ngāi Tahu and the Department of Conservation.

Financial modelling undertaken as part of the business case indicated the proposed activities were commercially viable.

Profits from any visitor operations will be put back into continued restoration efforts on our lands. We are already working on pest eradication and the regeneration of the coastal podocarp and inland forests.

We are also keen to develop a sponsorship programme where people can buy or sponsor a trap or camera to assist in pest eradication efforts.

We cannot do this alone and RMLT works closely with the Predator Free Rakiura group and is looking at opportunities

to develop a MOU with the Rakiura Titi Island administering body which has a wealth of experience with endangered species work.

2020 arrived with the news of the Covid19 Pandemic, which has affected every facet of normal life across the globe. We were forced to cancel this years' AGM, as in May we would normally have sent out the first papers for this hui, but instead we sent a letter that the AGM would be postponed until a time we could be sure that we could have gatherings of over 100 people and that it would be safe for our beneficial land owners to travel, and that there were actually available means to travel. After taking advice we will now hold an AGM later in 2021 at which time there will be the usual election for two trustees standing down by rotation. (These Trustees can also stand for re-election.)

We welcome interest from those who would like to understand what being a trustee involves. We have produced a Trustees handbook to guide new trustees and offer the opportunity for prospective trustees to meet with us to discuss what being a RMLT Trustee entails.

At the same time as we sent the postponement notice, we also included an owner's update form and a request to beneficial landowners to ensure they were on the RMLT register.

This has resulted in a significant number of new successions plus several more whanau, getting their details on the lists. Preferred communication is email, but you can update your details via the website if you want to request a hard copy or you can write to us.

Predator Free Rakiura continues on its very positive road and are currently waiting to see if they have been successful with an application for funding to move into the next phase of the project. This will test whether we have the science to achieve what will be the biggest Predator Free island in the world - Rakiura.

The slipway continues to be a worthy asset to us. We have signed off on some improvements which will enable more and bigger vessels to be worked on the slip which will create further income.

Since NZers have not been able to travel overseas Rakiura has been quite busy for this time of the year, tourist numbers are up and we hope that this will carry on through into the season.

Again we wish to thank all our beneficial owners for their support as it gives us strength that as we map our careful and planned restoration of our whenua, we are united in our vision and purpose.

I tae mai a 2020 me ngā purongo o te mate urutā o Covid-19 i pa ki ngā ahuatanga katoa o te ao ora puta noa i te ao. I akina mātou ki te whakakore te Hui a Tau, i te marama o Haratua i te wa i tukuna e mātou ngā pepa tuatahi mō tēnei hui engari i tukuna e ta mātou he reta ka hiki te Hui a Tau kia ta ērā ano ki te wā i tino mohio mātou ka nui ake i te 100 tangata ka huihuinga, me hoki e pai ana mo ngā rangatira whenua whaihua kia haerere ana kei te wātea ngā huarahi ki te haerere. Whai muri i te tohutohu ka mahia e tātou he Hui a Tau i waenganui o te tau 2021, a tērā wā ka tu te kowhiringa pōti mo ngā kaitiaki e rua ka tūru takirua (Ka taea hoki e ēnei kaitiaki te tu mō te pōti ano).

RWEL REPORT

RAKIURA WILDLIFE EXPERIENCE LIMITED

Tena koutou katoa,

Our partnership with Real Journeys with Wild Kiwi Encounters continues to mature and strengthen even in the face of the calamitous impact of Covid 19. We have jointly remained focussed on the future.

Pre Covid-19, the quality of our Kiwi viewing experience, resulted in glowing consumer reviews on social media, and reflect the professional management and staff passion for their mahi.

While competition in Kiwi viewing increased on Rakiura, demand for our tour has remained high. This is largely a result of effective advertising centred on making Rakiura an iconic global destination. Our national taonga, the kiwi, in its habitat, attracts both NZ and overseas visitors. Our offering differs from our fledgling competitors in that it includes a boat ride and a unique beach location.

The Kiwi viewing venture performed well financially despite lockdown, and the joint cash reserves held within the partnership were increased.

The Directors are thrilled with the PGF funding allocation which will cover stage one, Oneki, of a new Rakiura walk.

The project is structured to allow Oneki to be a stand-alone operation offering more opportunities for kiwi spotting, other guided walks and regenerative tourism where visitors are involved in or help fund our predator free goal.

It will also allow us to tell the history of the Old Neck, including our whakapapa and our relationship with the whenua. Incorporating our history and the current restoration story into a unique guided walk product is our goal. The Directors are committed to ensuring our tikanga underpins all our planning and delivery.

The impact of COVID-19 did impact on our returns from hunting, caused by the lockdown between March and May. The good news is that bookings in the 2020-2021 year are now up significantly. In general, the visitor numbers to the Island, since lockdown ended have been very encouraging and we are planning for a positive future.

The waterfront building has, in the past, proved to be a difficult asset to derive any income from but we have been encouraged by a recent increase in interest in leasing it.

The slipway, which forms part of the waterfront portfolio, is undergoing structural improvements to cater for larger vessels, with the potential to increase revenue. The slipway is a great example of a Trust/Oban Community partnership that benefits everyone on Rakiura.






Operating Profit is made up of cash profit less depreciation, while comprehensive income includes an adjustment for both realised and unrealised gains on investments. The financial performance graph below includes all sources of income included in comprehensive income. As you can see, this is down again this year and did not exceed expenses incurred.



Operating Income is down overall for the 2020 year, This is due to Covid-19 which required approximately half of the hunting trips to be cancelled.




Dividend and interest income combined make up the majority of the income for 2020 financial year. Interest income is up due to an increase in the number of Bonds held. As mentioned previously, Hunting income is down due to Covid-19. Some of these trips have been rebooked for 2021.



Administration and governance expenses again make up half of the expenses for the Group, with administration making up 22% of total expenses (down from 23% in 2019), and governance making up 34% of expenses (up from 27% in 2019). Owners administration expenses have increased slightly this year due to the push to obtain shareholder contact details. This has gone from 2% of total expenses in 2019 to 4% of total expenses in 2020.






